2. Enclose a one-time fee of \$50. Make your check out to "Bryan Brothers Foundation, Inc." \$25 of the fee is a tax-deductible donation and \$25 goes to the MVA to produce the plates as noted by the circled item on form.
3. You must have current & permanent Maryland plates to apply. You do not have to wait until your renewal and there is no recurring fee. When you get your "Crab" plates by mail, simply return your plates to MVA.
4. Please mail your application and check for \$50.00 to the address below.
